

# Quilt Show Rules

## A Splash of Color

### Sept 24<sup>th</sup> and Sept 25<sup>th</sup>, 2010

1. All entries must have been completed after September 2006, not previously shown in the Cabarrus Quilt show.
2. All entries must be clean, free of pet hair, tobacco and/or other odors and free of stains, rips, holes etc...*The Quilt show committee reserves the right to refuse an entry that has stains etc..*
3. All quilts must have three layers joined by quilting. Exception is in category other and wearable Arts.
4. All quilt entry's must be pieced and/or quilted by the entrant.
5. All embellishments must be secure and may not require special handling or folding.
6. Each quilt must have its own entry form. ***All quilt show entry forms must be received by August 9<sup>th</sup>, 2010.***
7. All entries must include the name of the pattern/designer/book/ or indicated original design. Entry form must be complete with all required information. A photo of the quilt must be attached to the entry form. This is used for insurance purpose and hanging. The photo can be printed on plain copy paper.
8. All quilts must be able to be hung using standard procedures; do not send hanging rods or any kind of hardware or special hanging instructions.
9. All entries must have a label sewn on the back lower-right corner with the quilt name, maker's name, address and date completed. *Judged quilts must have a piece of muslin pinned over the label so you can not see the information.*
10. Each quilt must be placed in a pillow case or blanket bag with the entrants name, address, phone number and quilt name written on the upper left-hand corner of the pillowcase or blanket bag. (Blanket bags can be purchased for \$1.00 for small and \$2.00 for large). Please purchase bags before drop off date. Wearable Arts can be put on a hanger and place in a garment bag or some type of protective covering.
11. Judging fee is \$10.00 per person regardless of the number of quilts entered.
12. A Limit of 2 quilts per category per person.

*The Quilt Show Committee reserves the right to refuse any quilt not meeting the established rules.*
